

Town Board Meeting
June 3, 2024 5:30pm
Bradley Town Hall

Chairman Kevin Koth called the meeting to order at 5:30pm. Supervisors Joan Hilgendorf, and John Crass were present. Supervisor Jennifer Bishop was absent.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$150,785.41 Equipment & Construction Fund - \$399,687.14; General Savings Account - \$143,055.77; Checking Account - \$227,720.61; Capital Outlay - \$35,000.00; Cemetery Fund - \$70,586.58; Re-Evaluation - \$90,000.00; and Greenwood Cemetery CD - \$12,609.15.

Minutes of previous meetings: Board of Review, Public Hearing and Monthly Meetings on May 13, 2024, Hilgendorf/Crass motion to approve. Motion passed 3-0

Clerk's Business:

- G. Koth/Crass motion to approve the fireworks permits for Road Lake Pub and Steve Brummond. Motion passed 3-0

Plan Commission: Crass/Koth motion to approve the minor subdivision request by GTLP LLC (Tim Shartis) to create three lots in a rural residential 2 zoning district. The property is located at N11412 County Road U, Tomahawk. The private road will not become a town road without meeting town specifications at property owner's expense. Motion passed 3-0.
Crass/Hilgendorf motion to approve the petition for modification of subdivision ordinance. Creating a lot(s) that does not meet the requirements of 30 feet of frontage on a public road. Request by GTLP LLC (Tim Shartis). Motion passed 3-0.

Waste/Recycling: None

Cemetery: The lot owned by the cemetery on Greenwood Road is being surveyed. No other action at this time.

Building & Grounds: Crack filling of the parking lot has started. Adam will work with the contractor regarding timing.

Road Report: No action was taken on the extended warranty or the payment on the new plow truck. Chairman Koth and Adam will follow up with the sales rep. to have him answer any questions. Kyes Road has been addressed. The speed limit on Tannery Road will remain at 55mph.
