Town Board Meeting August 12, 2024 5:30pm Bradley Town Hall

Supervisor Joan Hilgendorf called the meeting to order at 5:30pm. Supervisors Jennifer Bishop and John Crass were present. Chairman Kevin Koth was absent.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$150,834.91 Equipment & Construction Fund - \$215,838.14; General Savings Account - \$143,079.67; Checking Account - \$145,105.43; Capital Outlay - \$28,475.00; Cemetery Fund - \$70,586.58; Re-Evaluation - \$81,000.00; and Greenwood Cemetery CD - \$12,609.15.

- B. Crass/Bishop motion to approve the operator license for Douglas Jensen, Hilary Schoenenberger & Levi Augustine. Motion passed 3-0
- C. Hilgendorf/Bishop motion to approve the liquor license and cigarette license for True North #859. Motion passed 3-0

A property owner from Rapel Road inquired about parking on town right-of-way. He had spoken with attorney Fred Schaeffer regarding the town's ordinance #39 on parking on town roads. After a lengthy discussion it was decided that this item would be tabled until the September 9th meeting after the town board could get more information from the town's association attorneys regarding our ordinance and what is allowed and not allowed when it comes to parking in town right-of-way. It was decided that until that meeting all signage would remain the same until more information is collected.

Bishop/Crass motion to approve Town of Bradley ordinance #2024-2 moving the treasurer's position from elected to appointed. This will now be placed on the November 5th ballot as a referendum question. Motion passed 3-0

Waste/Recycling: Supervisor Crass will get someone out to fix the rams on the compactors.

Parks & Beach: A building and some trees will be removed at Crystal Beach. Supervisor Bishop is also working with the DNR to get a retaining wall up.

Building & Grounds: Hetzel's fixed the leak in the treasurer's office. Birchfield Nursery will be contacted about replacing the tree at the town hall that had died and was removed.

Road Report: Mowing of the shoulders on all town roads has begun.

Other business not requiring board action: The port-a-potty at Crystal Beach will be moved to Kahle Park to accommodate the rental in September over Harley weekend. The board of review will meet on September 9, 2024, at 3:00pm to adjourn the board of review to a later date.
