Town Board Meeting September 9, 2024 5:21pm Bradley Town Hall

Supervisor Chairman Kevin Koth called the meeting to order at 5:21pm. Supervisors Joan Hilgendorf, Jennifer Bishop and John Crass were present.

The Treasurer's report was presented as follows: Building & Office Equipment Fund-\$150,857.30 Equipment & Construction Fund - \$210,204.75; General Savings Account - \$143,079.67; Checking Account - \$209,280.61; Capital Outlay - \$28,475.00; Cemetery Fund - \$70,586.58; Re-Evaluation - \$81,000.00; and Greenwood Cemetery CD - \$12,609.15.

Minutes of previous meetings: Regular monthly meeting August 12, 2024, Hilgendorf/Bishop motion to approve. Motion passed 4-0

Clerk's Business:

- A. Payment of vouchers #9155 through #9207 Hilgendorf/Crass motion to approve. Motion passed 4-0
- B. Hilgendorf/Bishop motion to approve the operator license for Michelle Cherney, Roni Jo Harkness, Samantha Lund, Deborah Ohm & Dana Zehner. Motion passed 4-0

Koth/Hilgendorf motion to approve Resolution 2024-8 for altering/widening Half Moon Lake Road. Motion passed 4-0

Resolution to vacate a public road stub off High View Road on William Cook's property was tabled at this time per Attorney Randy Frokjer.

Discussion was had regarding parking in town right-of-way. State Statue 349.13 grants authority to towns regarding their right-of-way and gives the town the right to have an ordinance in place which the Town of Bradley does. There are currently eighteen locations within the town that have no parking signs. The signs will remain in place on Rapel Road.

Supervisor Bishop gave an update on broadband. The town will need to endorse an ISP once one is received.

Waste/Recycling: Supervisor Crass will follow up with ACE Equipment to see if they have found any issues with the compactors.

Parks & Beach: Supervisor Bishop received the land use permit to complete work at Crystal Beach. A gazebo has been purchased to be installed; Foley's will be removing some trees and working on getting a quote to update landscaping all at the beach.

Building & Grounds: Foley's planted the new tree at the town hall. Supervisor Hilgendorf would like a quote to have the carpet replaced in the town hall meeting room.

Road Report: Grubbing and various road projects with the county will be taking place in October.

Other business not requiring board action: The board thanked Ben Brown for his years of service on the Town of Bradley Plan Commission. Supervisor Bishop would like to have a special assessment ordinance in place for how the town disburses funds to the various lake districts within the town. This item will be placed on the October agenda.
